# ELECTION NOTICE

## NOMINATIONS

Nominations are hereby invited on and from 5pm Sunday 14 January 2024 for the following positions:

- **Chair**
- **Three (3) Deputy Chair**
- **Treasurer**
- **Three (3) Directors**

Nominations must be in writing, signed by the candidate and at least 2 financial full members who are entitled to vote. The candidate must be a life or financial Bowling member of the club. Nominations must comply with the club's Constitution, by-Laws and any relevant directions given by the Returning Officer.

A candidate can nominate for more than 1 position, but may only be elected to 1 position. No eligible member shall nominate more candidates for any position than the number to be elected for each position.

## CANDIDATE PROFILE

A candidate may submit a Candidate Profile Form to the Returning Officer by the close of nominations 5pm, Sunday 28 January 2024, details from which will be included in a Candidate Information Sheet which will accompany voting material when it is published.

Any defect must also be rectified before the close of nominations. A candidate may only withdraw his/her nomination by submitting a written, signed statement so as to be received by the Returning Officer prior to the close of nominations.
