#### NOMINATIONS

Nominations are hereby invited on and from **11am, Sunday, 9 November 2025** for the following positions:

Nominations must be in writing, using the prescribed Nomination and Candidate Profile Forms and signed by the candidate and at least two financial members who are entitled to vote. The candidate must be a Life, financial Bowling or financial Social member of the Club. Nominations must comply with the Club's Constitution, By-Laws, and any relevant directions given by the Returning Officers.

#### ROLL OF ELECTORS

The roll of persons entitled to vote in this election will close at **11am on Sunday, 23 November 2025**.

#### BALLOT

At **11am on Sunday, 23 November 2025**, the Returning Officers will open the ballot box, confirm the number of nominations received, and, if required, conduct a draw to determine the order of candidates' names on the ballot paper. Candidates or their representatives are invited to attend the draw. If an election is required (i.e. more than three nominations are received), a **Notice of Election**, including candidate profiles and details of the voting process, will be **published on Monday, 24 November 2025**, and displayed on the Club noticeboard and website in accordance with Rule 28.2(n)(ii) of the Constitution.

Voting will take place **in person at the Annual General Meeting on Sunday, 30 November 2025**. No pre-voting or absentee voting will be available.

#### FURTHER INFORMATION

Any defect in a nomination must be rectified before the close of nominations. A candidate may only withdraw their nomination by submitting a written, signed statement received by the Returning Officers prior to the close of nominations.

Nomination & Candidate Profile Forms can only be lodged via the ballot box located at the Club's premises: 88-92 Piper Street, Lilyfield NSW.

The Returning Officers appointed for this election are Liam Potter and George "Ronnie" Court, who will conduct the election in accordance with the Club's Constitution and relevant By-Laws.
