Opening of voting (11:00am):

The AGM will commence at 11:00am. Once the meeting is declared open, the Chair will announce that voting for Directors is open and members may cast their ballots by placing them in the ballot box.

Voting window (11:00am to 11:20am):

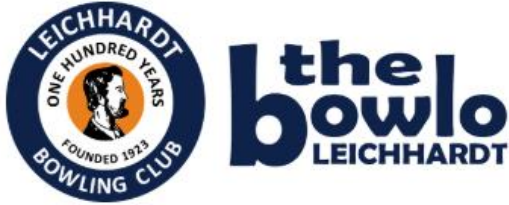
Voting will remain open for a defined period during the AGM to ensure all members present have a reasonable opportunity to vote. Members arriving after 11:00am may receive a ballot only if they present their Club membership card. No eligibility checks will be performed after 11:00am.

Closure of voting (11:10am):

At 11:10am the Chair will declare voting closed. No further ballots may be issued or accepted after this time.

Counting of votes:

Immediately upon closure of voting, the Returning Officers and scrutineers will take possession of the sealed ballot box and commence counting in accordance with Rule 28.2. Counting will occur while the AGM proceeds with early agenda items.
